Sir:-

I beg to acknowledge receipt of your communication of December 20th, with a letter addressed to His Honor, the Mayor, from Mrs. E. Jeanne Bolte, principal of Bolte's School, 1821 Lyons Street.

The first part of her communication deals with a complaint against the Board of Health for keeping out of her school a pupil ill with disease and that she disregarded the regulations of the Board and took the child into her institution. I have directed the attached letter to Mrs. Bolte, requesting her to call upon me to verify this, and if it be so, I shall read to her the ordinances and state law covering the return of children ill with communicable disease to school.

As to the part of her letter dealing with the question of treatment of cases of pneumonia, please be informed that this office could not consider any cures nor suggest the same in our institutions. The medical service to all patients therein is under the guidance and direction of the visiting staff who are professors of medicine and surgery from the University of California and Stanford Medical School.
